Where as the Point Baker Community Association is the non profit corporation representing the people of the village of Point Baker located on Prince of Wales Island.

And where as the passage of House Resources Bill 3560 cited as the Southeast Alaska Native Land Entitlement Finalization Act would be extremely harmful to the residents of Point Baker for the following reasons;

We rely on the surrounding National Forest Lands for the continuance of our subsistence way of life.

We use timber from the National forest to build our homes, and firewood to heat our homes.

We use National forest Roads to access our community and to access lands used for subsistence hunting and fishing

We rely on a healthy surrounding forest to provide good stream habitat which is crucial to the mainstay of our local economy which is commercial fishing.

We use the National Forest for much of our community's recreation and for local recreational businesses.

And where as all of these uses take place on land which would be conveyed to Sealaska Corporation under H.R. Bill 3560.

And where as the transfer of land under H.R. Bill 3560 from the National Forest which is managed for multiple uses to Sealaska Corporation whose stated goal is intensive timber extraction would be detrimental to all of these community uses.

And where as the intended development of large scale tourism operations on land to be conveyed in our vicinity would cause increased competition to our local subsistence and commercial fisheries.

And whereas the residents of Point Baker were not included in any discussions as to which lands would be best suited for conveyance to Sealaska Corporation under this bill.

The Point Baker community Council strongly opposes the passage of House Resources Bill 3560.
